
Main Campus Viewing

4. New Definition of "Student" in Student Handbook: Request for Council Approval

Kathleen Kerr, Vice President for Student Affairs

- Why this change?
- Current definition of "Student":

On page 17 of the 2023-2024 student handbook and within the Code of Conduct, student is defined as: "Student" includes all persons taking courses, both full-time and part-time, pursuing undergraduate, graduate, or extension site studies. There is some explanation of different "student-types" in regards to admissions processes on this page of the catalog but nothing (that we know of) that defines a student broadly beyond what is in The Code.

Proposed new definition:

"Student" includes any person who has accepted admittance to the University for student status or who is currently registered or enrolled as an undergraduate, graduate, professional student, or certificate program participant, whether matriculating or non-matriculating, full-time or part-time, resident or commuter or on-line, paid or delinquent, or who has a pending appeal of an academic dismissal or student conduct matter. Such a person shall also be considered a student during intersession/summer periods, at University-sponsored commencement events in which they are a participant, and those who are not officially enrolled for a particular term but who have a continuing educational relationship with the University.

Hewitt Hall Renovations

Toured Hewitt Hall with Mitch Fields, Associate Vice President for Facilities Services, and Jennifer Knapp, Dean, School of Communication, Media, and the Arts. We took the time to see progress on the multi-million dollar renovation work going on at Hewitt Hall at SUNY Oswego.

The renovation of Hewitt Hall is an \$80 million project, capping off over \$124 million in renovations (Tyler Hall renovations were \$44 million) for the School of Communication, Media and the Arts (SCMA). Hewitt will be the new home for the departments of Communication Studies and Cinema and Screen Studies, and the Graphic Design, Interaction Design, and Illustration academic programs within the Department of Art and Design.

As we continue to advance our mission and vision 4040, these world-class facilities will place SCMA and SUNY Oswego solidly at the forefront of all institutions in the nation with similar programs. Highlights include two broadcasting studios, a podcasting studio, a newsroom, a white box gallery, a film screening room, an animation lab, a virtual reality suite, a ballroom that serves as both a music performance space, and numerous specialized labs and classrooms. **This project is set to be completed in Fall 2025**.







Retention of New Fall Undergraduates into their First Spring


