General Articulation Agreement Corning Community College and State University of New York at Oswego

SUNY Oswego and Corning Community College are dedicated to a strong, formal, coordinated transfer and articulation process which will be of great benefit to students transferring from Corning Community College to SUNY Oswego. This document states the conditions under which SUNY Oswego will accept credits earned by students attending Corning Community College toward the attainment of a Bachelor's Degree from SUNY Oswego and thereby enhance the number and quality of learning options for its students and alumni.

Corning Community College and SUNY Oswego will cooperate to:

- 1. Strengthen the partnership that currently exists between Corning Community College and SUNY Oswego.
- 2. Provide barrier-free movement from the associate to the bachelor's degree for students enrolled at Corning Community College.
- 3. Eliminate unnecessary obstacles for Corning Community College transfer students who need to satisfy SUNY Oswego's General Education Requirements.

In order to achieve these goals, Corning Community College and SUNY Oswego enter into the following Agreement.

Admissions

Students from Corning Community College planning on completing their bachelor's degree should apply to SUNY Oswego the semester prior to enrolling at Oswego. Applications for admission are available at www.oswego.edu/apply. Transfer students must also submit an official transcript from Corning Community College and any other colleges or universities previously attended. Transfer students who have completed fewer than 24 credit hours at the ti.me of their application must also submit official high school transcript.

GPA requirements vary by major and number of credits completed at time of application. A cumulative GPA of 2.3 will be considered for transfer students applying to most majors with at least 24 credits hours completed. If less than 24 hours are completed at the time of application, a minimum GPA of 2.5 will be required. All majors leading to education certification require a 3.0 for consideration.

Transfer applicants for the fall semester who have a completed application on file in the office of Admissions by March 1 will be given priority for admission. Applicants for the spring semester who file by November 1 will be given priority for admission.

Transfer of Credits

Students who have completed an Associate in Arts, Associate in Applied Science or Associate in Science degree will be accepted as juniors. Although grades of "D" are transferable; they may not be used to satisfy major or cognate (major-imposed) requirements in some programs. A maximum combined total of 54 credit hours in any one discipline can be applied to the Bachelor of Arts degree requirement.

It should also be noted that the student must complete:

- A minimum of 30 credit hours at SUNY Oswego
- One-half of the major coursework at SUNY Oswego
- A minimum of 42 credit hours of coursework at the 300- or 400-level

General Education Requirements

Students who transfer to Oswego after completing the 30-credit SUNY General Education Framework (SUNY GE, Fall 2021) or the 30-credit SUNY General Education Requirement (SUNY GER, Fall 2010) or the equivalent at a previous institution are exempt from all of Oswego's specific general education requirements. Upon acceptance at Oswego these transfer students will have completed the General Education Requirement at Oswego.

Students who transfer to Oswego who have not completed SUNY GE or SUNY GER prior to transferring will be required to complete the remaining SUNY Oswego General Education requirements.

SUNY Oswego will accept all General Education classes approved to meet SUNY GE/SUNY GER categories. A list of courses that will be accepted by Oswego for General Education credit can be found on the SUNY General Education website at https://www.suny.edu/attend.academics/genedreg/

Major Requirements

Students planning to transfer to SUNY Oswego should follow the recommended course requirements for their intended program of study at Coming Community College. Students are highly encouraged to seek transfer counseling from a designated Coming Community College or staff member or a SUNY Oswego Admissions Counselor for proper course selection, which varies by program of study. Bachelor's Degree Programs

Students may transfer into any bachelor's degree program given they meet the admission requirements for the particular program of study.
